Notice is hereby given that the Placer County Planning Commission will conduct a public hearing, on the date and time noted above, to consider on its consent agenda, a request from Squaw Valley Resort, LLC, for approval of a three-year Extension of Time, for a previously approved Conditional Use Permit that allowed for the replacement of the existing Red Dog Chairlift with a new high-speed, detachable, six-pack chairlift. The subject property, Assessor's Parcel Numbers 096-010-012-000, 096-221-019-000 and 096-221-038-000 comprises 4,000 acres, is currently zoned FR (Forest Recreation), VC (Village Commercial) and HC (Heavy Commercial) and is located at the ski area at 1960 Squaw Valley Road, in the Olympic Valley area. The Conditional Use Permit was originally approved by the Planning Commission on March 28, 2012. The Planning Commission will also consider a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program that were prepared pursuant to the California Environmental Quality Act and was adopted at the same time.
